**PRIVACY ACT 1988 AUTHORISATIONS/AGREEMENTS**  
**AUTHORISATION TO ACT ON BEHALF OF INDIVIDUALS**

**A. SECTIONS APPLICABLE TO APPLICANT/S WHO ARE NATURAL PERSON/S**

1. Acknowledgment of Disclosure of Credit Information to a Credit Reporting Agency

I/we acknowledge that the Privacy Act allows the credit provider identified in my/our application for finance (the "Approved Credit Provider), which **Leaselink Business Finance** may approach in arranging my/our finance (hereinafter the Approved Credit Provider), to give a credit reporting agency certain personal information about me/us in relation to my/our application for finance.

The information which may be given to an agency is covered by the Act and includes:

- \* Such permitted particulars about me/us which allow me/us to be identified;
- \* The fact that I/we have applied for finance and the amount;
- \* The fact that the Approved Credit Provider is a current credit provider to me/us or has ceased to be a credit provider to me/us;
- \* Payments which become overdue more than 60 days, and for which collection action has commenced;
- \* Advice that payments are no longer overdue;
- \* Cheques drawn by me/us which have been dishonoured more than once;
- \* In specified circumstances, that in the opinion of the Approved Credit Provider, I/we have committed a serious credit infringement;

By virtue of this declaration, I/we understand that **Leaselink Business Finance** has informed me/us of the disclosure policy to a credit reporting agency of information about me/us by Approved Credit Providers and so authorise such disclosures.

2. Agreement/Authority by Applicant/Customer for Approved Credit Provider to Perform Certain Permitted Actions Concerning a Finance Application or Transaction

I/we agree that, if it is considered relevant in assessing my/our application for personal credit, the Approved Credit Provider may obtain a report about my/our commercial activities or commercial credit worthiness from a business that provides information about the commercial credit worthiness of persons.

I/we agree that, if it is considered relevant in assessing my/our application for commercial credit, the Approved Credit Provider may obtain from a credit reporting agency a credit report containing personal credit information about me/us.

I/we agree that the Approved Credit Provider may disclose to a guarantor credit information relating to me/us and may also provide such information to a person who is considering whether to become a guarantor, for that purpose.

I/we agree that if finance is provided to me/us by the Approved Credit Provider, I/we authorize the Introducer to obtain from the Approved Credit Provider and for the Approved Credit Provider to disclose to the Introducer any report or information concerning either me/us or that finance that it may require in order to:

- Assist me/us in understanding and meeting my/our obligations to the credit provider in relation to that finance;
- Advise me/us regarding my/our finance requirements;
- Ascertain any amount required to be paid to the Approved Credit Provider in relation to the finance.

I/we understand that this paragraph may be deleted if I/we do not agree. I/we understand that this authority will continue for the duration of the finance unless and until I/we revoke it by notice to **Leaselink Business Finance** and the Approved Credit Provider.

3. Authorisation to Act on Behalf of Individuals

For the purposes of arranging the finance which is the subject of my/our application, the details of which appear below, I/we authorise **Leaselink Business Finance** to obtain a report about my/our consumer or commercial credit worthiness from a credit reporting agency or a commercial credit reporting business or from a credit provider or from a trade supplier as advised in my application.
